This order shall dispose off the appeal filed by Shri Sandeep Chatterjee FATIP/A/E/21/00001 in respect of ID No.49.

The appellant in his RTI application dated 11.12.2020 requested for the following information :

1. On which date is the Memorandum of Charge Sheet against Shri Sandeep Chatterjee, Professor & Head, Department of Direction & SPW dated? (Reference No.A-19011/3/2008-Est.)
2. On which date was the Memorandum (Reference No.A-19011/3/2008-Est.) signed?
3. Who was the incumbent Chairman, FTII (Disciplinary Authority) on the respective days when the memorandum (Reference No.A-19011/3/2008-Est.) was dated and signed?
4. Please provide the name of the person who signed the memorandum (Reference No.A-19011/3/2008-Est.)

Note : If the information is denied or partially provided, please mention the relevant clause(s) of the RTI Act for the same.

The PIO, vide his reply dated 11th January, 2021 provided the information.

The appellant contends that the necessary information is denied in an arbitrary manner.

Since the above information is indeed part of ongoing disciplinary process of the employee and can't be disclosed to the appellant, the PIO's invocation of Section 8(1)(h) of RTI Act stands.

The appeal is therefore disposed of.

If he is not satisfied with the information provided, he may file an appeal before **Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi - 110 066** within the stipulated time.
