This order shall dispose off the appeal filed by Shri Shaikh Atik Rashid in respect of I.D. No.06.

1. Present Shri Shaikh Atik Rashid, Appellant on 24.05.2017
2. Present Shri Amit Tyagi, PIO/Dean (Films) and Shri Dhiraj Meshram, Associate Professor Production, FTII, Pune
3. All present heard.
4. The appellant in his RTI application dated 17th February, 2017 had sought to inspect files containing " Production of all academic projects made since January 2015 including Diplomas, Dialogues, Playbacks, DVs, Documentaries both for Film and TV courses shot on film and in digital format and the shooting ratios for all these projects". The PIO in his reply had said that the information can only be provided if the applicant could clearly pin point as to what he wants. The PIO has contended that there are various projects going on at one point in time in the institute and in this case, there were more than 123 projects since January, 2015.

Unless, it is clearly & specifically pointed out as to which information is required, it becomes extremely difficult to consolidate and provide information. On being asked to be more specific, the appellant said that he wants to inspect files relating to shooting ratios of academic projects of 2008,2009 & 2011 Batches. The PIO is directed to facilitate the same within 7 days from the issuance of this order. The appeal is therefore disposed off.

5. Ordered accordingly.

If you are not satisfied with the information provided, you may file an appeal before **Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi - 110 066** within the stipulated time.
