- 1. This order shall dispose of the appeal filed by Shri Sanjay J. Chandekar in respect of ID No.66.
- 2. The appellant in his Original RTI application dated 11.10.2021 had sought information as follows:
 - 1. Please furnish the rules & regulations regarding the maximum tenure of the Internal Committee.
 - 2. Please furnish the rules & regulations regarding the maximum tenure of the External Member of the Internal Committee.
 - 3. Please furnish the rules & regulations or guidelines about formation of an Internal Committee at the Central Government offices & at Central Government Autonomous Institutions.
 - 4. Please supply the information or documents or a noting whether a Contractual Woman employee for a short term contract of 2 years or so can be a Chairperson of the Internal Committee, if the tenure of IC itself is for 3 years.



- 5. Please furnish the rules, regulations & guidelines regarding honorarium or remuneration to be given to the all Internal Committee Members including the external expert per sitting.
- Please furnish the rules, regulations & guidelines regarding any special lumpsum honorarium or remuneration to be given to the appointed or nominated External Expert of the Internal Committee at the Central Govt. Offices.
- 7. Please furnish the complete procedure of the steps for conduct of Inquiry in Complaints of Sexual Harassment or at Work Places Applicable to the all offices & autonomous institutes of the Ministry of Information & Broadcasting of Central Government and if any changes are there from time to time and the office memorandums (O.Ms) till the date.
- 8. Please furnish the procedure or mechanism to lodge the complaint against the Internal Committee itself to the Woman Commission if the committee is not observing the proper inquiry procedure.
- 9. Please furnish the procedure or mechanism to lodge the complaint against the Internal Committee itself to the concerned office in which IC Committee has been set if the IC Committee is not observing the proper guidelines or procedure.
- 3. The PIO sent a reply through his letter dated 14.12.2021.
- 4. The Appellant has made the present appeal disputing on the reply given by the PIO.
- 5. The Appellant has mentioned in his appeal that with reference to the point No.4 in his RTI application, it is requested to give him the supportive document examples (but not a copy of the law, which he already have) stating the Act does not prohibit any woman employee appointed on contract basis to hold the position. Also, please supply any other document/circular/order of the Central Government office where a contractual employee has been posted on the said position and regarding the point No.9 in his RTI application he asked for the details of the Grievances Redressal Mechanism, its complete procedure to handle any complaints & information about the current members in Grievance Redressal Committee & the past members of it.



- 6. 1. For Serial No. 4, the PIO has already provided the desired information. Now Appellant has asked for *supporting documents*, which is not available on record.
 - 2. For Serial No.9, the PIO has already furnished the reply stating that no such provision on grievance is available in the RTI Act, 2005. In case of grievance of an employee, Registrar, FTII is a designated official (Grievance Officer) at the Institute.
- 7. In view of the above, the undersigned being the First Appellate Authority hereby upholds the decision of the PIO.

The appeal is therefore disposed of.

If you are not satisfied with the information provided, you may file an appeal before Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi – 110 066 within the stipulated time.
