This order shall dispose off the appeal filed by Ms. Laxmi FATIP/A/2018/60007 in respect of ID No.17.

1. Present PIO, Dean(Films)
2. Present CPIO, Shri S K Dekate
3. The appellant was not present in the hearing. No written submission has been made by the appellant.
4. All Present Heard.
5. The appellant in her RTI application dated 03.10.2018 asked for the following information:

*(i) send the course wise, semester wise syllabus copies of all the courses offered by the Film and Television Institute of India (FTII);*

*(ii) send the course wise, semester wise list of books recommended/Reference Books/Text Books/recommended reading materials etc of all the courses offered by Film and Television Institute of India;*

*(iii) send the course wise, semester wise videos and images using in the theory & practicals of all the courses offered by Film and Television Institute of India.*



6. The appellant has contended that CPIO has provided incomplete information and has further asked for

i) *course wise, semester wise list of books recommended/Reference Books/Text Books/Recommended Reading materials etc are not there in the prospectus*

ii) *course wise, semester wise videos and images using in the theory& practicals of all the courses did not give.*

7. The PIO has contended that FTII runs 11 full time courses in addition to various On-Campus courses including the Film Appreciation Course, Writing for TV fiction, Digital Video editing etc. Further there are several short courses running across the country under FTII's Skilling India in Film & Television programme. FTII's library has more than 34,000 titles for reference. Therefore, unless it is clearly specified as to what information is sought, it becomes extremely difficult to provide information.

#### 8. Decision

The appellant here is very vague and does not pin point the particular information she wants to obtain from FTII. The Appellant is, therefore, advised to be more specific and identify the information she wants to obtain from the respondent and make a de novo request to the CPIO for the same, if she so desires.

9. Ordered accordingly.

If you are not satisfied with the information provided, you may file an appeal before **Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi - 110 066** within the stipulated time.
