- 1. This order shall dispose of the appeal filed by Shri Sanjay Chandekar in respect of ID No.84.
- 2. The appellant in his Original RTI application dated 23.07.2022 had sought following information:
 - 1. Pl. provide Photostat copies of all the Newspaper Cuttings/ Clippings from FTII Book Library Newspapers regarding '139 Days Strike' and the protest of FTII students continued after that in 2015.
 - 2. Pl. provide Photostat copies of All the Newspaper Cuttings/ Clippings from FTII Library regarding all strikes/ protests/ agitations from 2016 till today.
 - 3. How many & which Newspapers were taken FTII for the Library in 2015 & 2016?
 - 4. Pl. provide the list of Daily Newspaper taken for the Registrar &/or his office for 2019-20.
 - 5. Pl. provide the list of Daily Newspaper taken for the Director &/or his office for 2019-20.
 - 6. Pl. provide the year-wise list of Daily Newspapers taken for Dean (TV) &/or his office for 2019-20.
 - 7. Pl. provide the year-wise list of Daily Newspapers taken for Dean (Films) &/or his office for 2019-20.
 - 8. Pl. provide the year-wise list of Daily Newspapers taken for any other departments for 2019-20.
 - 9. Pl. give the procedure earlier followed by the Book Library to give the Photostat copies of the FTII news to the authorities appeared in the newspaper.



- 10. Pl. inform about from about when the changes were brought in, instead of giving Photostat copies, the news clippings were sent by the E-mails by the Book Librarian.
- 11. Pl. inform about the current system to inform the FTII authorities from Book Library regarding any news that appeared in newspaper.
- 12. Was all news related to FTII were given or informed by the Library? In case if any news was missed to be given then pl. inform which procedure was followed by the Book Library later on.
- 13. News published about FTII in all newspapers which were in Book Library from August 2019 to January 2021.
- How many & which Newspapers were taken in FTII Book Library from December 2020 to January 2021.
- 3. The Appellant has made the present appeal disputing on the response from the PIO that the details not provided.
- 4. PIO has furnished the reply as per available records, the First Appellate Authority upholds the decisions of the PIO.

The appeal is therefore disposed of.
