This order shall dispose of the appeal filed by Shri Sandeep Chatterjee FATIP/A/E/21/00005 in respect of ID No.53.

The appellant in his RTI application dated 15.12.2020 requested for the following information :

1. Certificate of payment / salary slip of Mrs. Alka Singh for the month of June 2019. 2. Certificate of payment / honorarium for the paper correction of Mrs. Alka Singh for JET Examination, FTII 2017. 3. January, February, June Swipe Report/Biometric report sent to HoD Direction and Screenplay Writing. Films for the months of January to June 2019 other than that of Ms. Alka Singh in the department of direction and Screenplay Writing, Films.

The PIO (Chief Accounts Officer), vide his reply dated  $11^{th}$  January, 2021 had already sent the information related to B & A Section (Sr.No.1 & 2 above).

The appellant contends that partial information provided.

The PIO (Administrative Officer) in his reply dated 11.01.2021 denied the information (Sr.No.3 & 4) sought invoking section 8(1)(h) of the RTI Act.

Since the information is indeed part of ongoing disciplinary process of the employee and cannot be disclosed to the appellant, the PIO's invocation of Section 8(1)(h) of RTI Act stands.

The appeal is therefore disposed of.

If he is not satisfied with the information provided, he may file an appeal before Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi – 110 066 within the stipulated time.
