This order shall dispose off the appeal filed by Shri K. Jagadeeswaran in respect of ID No.56.

The appellant in his RTI application dated 23.10.2020 requested for the following information :

(1)FTII Director / Disciplinary authority Mr. Bhupendra Kainthola IIS had issued me an order dated 08.01.2020 regarding penalty of withholding of two increments of my pay and also relieved me from the duty of HOD, TV Camera Department. (2) I have submitted my humble request letter to appellate authority Shri B.P. Singh, Chairman of Governing Council letter dated 20.02.2020 about considering the facts sympathetically and to revoke the said order. However, FTII administration had implemented the above said order. Hence please provide me all attested photocopies of the following documents :

- (a) Date of my annual increment (Ref Point : ii)
- (b) The date of implementation of the above said Director's order dated 08.01.2020.
- (c) The date of my next increment, after implementation of the above said order.
- (d) Annual Financial losses, due to non implementation of my regular annual increment for the said period mentioned in the order. Please provide financial losses in year-wise (2020-21, 2021-22, 2022-23).
- (e) Please provide applicable GPF/CPF government rate of interest for the year (2019-20, 2020-21)

- (f) Please clarify that the above said order will affect my gratuity or not
- (g) Please provide me the financial losses in my gratuity due to implementation of the said order at the time of my retirement December 2023.
- (h) Please provide me the official correspondence made between Chairman of FTII and FTII office administration regarding the subject matter mentioned above (Point (i)(2))

The appellants contend no response within the time limit from the Administration PIO.

The contention of the appellants is correct and therefore accepted. However, the PIO, vide his reply dated 20th November, 2020 (*copy enclosed*) had already sent the information on 23.11.2020 by post.

The appeal is therefore disposed of.

If he is not satisfied with the information provided, he may file an appeal before **Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi - 110 066** within the stipulated time.

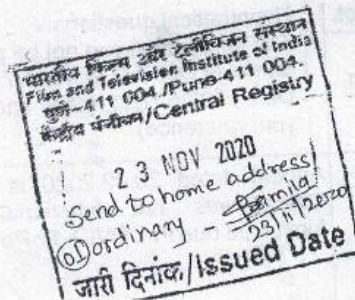
