ORDER

Date of RTI Application – 24.10.2019

Date of RTI Reply - 27.11.2019

Date of RTI Appeal - 11.12.2019

This order shall dispose of the appeal filed by Shri K. Jagadeeswaran in respect of I.D. No.40.

2. The appellant vide his RTI application dated 23.08.2019 had sought information on the following :-

- (i) Request for inspecting related file, file noting, to take notes and to take attested photocopies of the required pages regarding Canon5D Mark III camera which was stolen from the TV Camera Dept.
- (ii) Please provide all attested photocopies of the following documents regarding Canon 5D Mark III camera which was stolen from the TV camera Dept in the year 2014 :-
 - (a) Agenda and minutes of Governing Council meeting of FTII on Canon 5D Mark III camera
 - (b) Related FTII audit reports and objections and replies submitted by FTII administration
 - (c) Related CAG audit report and objections and replies submitted by FTII administration
 - (d) Internal committee (FTII) investigation report dated 5.3.2016 submitted to FTII administration
 - (e) FTII Chairman's note dated 15.6.2019 in this regard to take up the matter again now
 - (f) My FULL service book including details all leave period availed and vacation availed

3. The PIO, vide reply dated 27.11.2019 provided all the information as asked for by the Appellant.

4. In his RTI appeal, the appellant states that :

(1) As per instructions from FTII authorities, he has filed FIR with Deccan Gymkhana Police station on 17.11.2014 and a reply has been received on 10.03.2015 from Police station

(2) Again on 29.12.2015 another FIR has been lodged to find out the loss items. Later the police has sent a reply to FTII, which is not provided to me


5. The Appellant has asked for information in the Appeal which was not asked for in his RTI application dated 24.10.2019.

6. The appellant cannot raise fresh request for information at appeal stage.

7. In view of the foregoing, the appellant's contention that he has not been provided information as per provisions of RTI Act, does not hold ground. The appeal is therefore disposed of.

8. Ordered accordingly.

If the Appellant is not satisfied with the information provided, he may file an appeal before Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi – 110 066 within the stipulated time.


