**ORDER**

This order shall dispose off the appeal filed by Shri Shrikar Kishor Mote FATIP/A/2018/60005 in respect of ID No.15.

The Appellant in his application dated 25.06.2018 mentioned that he had applied for full time Acting course in FTII. His roll no. is 181150463 and he was first in waiting list of (SC) category. He had requested FTII to send his mark sheet of all rounds and also wanted to know mark sheet of selected (SC) candidate and general candidates.

The CPIO, vide reply dated 23<sup>rd</sup> July, 2018 mentioned that the information required could not be released then, as the examination process was yet to conclude. It was further stated that the information could be released after the admission process was over by August, 2018. The candidate was advised to keep track of FTII website for the same.

The CPIO has contended that till the examination process (including declaration of final result) is complete, any information regarding cut-offs/marks secured by a candidate can't be disclosed. Preservation of confidentiality of sensitive information such as marks secured by any candidate was of paramount importance as disclosing any information before declaration of the final result may compromise the integrity of the examination process. The CPIO further contended that it was informed to the candidate that information can be made available to him after the examination process is complete in the month of August, 2018.

The CPIO has stated that since the admission process for the year 2018 at FTII, Pune is completing in August, 2018 following information will be made available to the candidate:

1) Marks obtained by the candidate, Shrikar Kishor Mote at various stages of the examination process.

2) Cut off marks of SC and General categories.

The CPIO is directed to provide information at 1) and 2) above within 10 days.

The appeal is, therefore, disposed off.

If you are not satisfied with the information provided, you may file an appeal before **Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi - 110 066** within the stipulated time.
