This order shall dispose of the appeal filed by Shri H.D. Waghmare in respect of ID No.19.

4. The Appellant in his RTI application dated 23.01.2019 had asked that true copies of confidential reports with signature from 4.12.2009 to 31.12.2018 may be made available to him. The appellant had further asked in his RTI application "why not given promotion to the post of Assistant Security Officer till date."

The PIO/Administrative Officer, vide reply dated 22.02.2019 provided signed copies of the Confidential Reports except 2014-15, 2015-2016 and 2017-2018.

5. The CPIO is directed to provide signed copies of Confidential Reports for the year 2014-15 and 2015-2016 within 3 days. As regards to copy of confidential report for the year 2017-18, the same will be provided after getting it reviewed by the reviewing officer.

During the hearing, CPIO clarified that the post of Assistant Security Officer is not a promotional post, but direct recruitment post to be filled by open advertisement as per the existing Recruitment Rules. PIO/Administrative Officer is directed to provide the copy of existing Recruitment Rules for the post of Assistant Security Officer to the appellant within 3 days.

The appeal is, therefore, disposed of.
