ORDER

This order shall dispose of the appeal filed by Shri K. Jagadeeswaran in respect of ID No.24.

1. Present Shri K. Jagadeeswaran, Appellant on 21.05.2019
2. Present Shri G.M. Maske, PIO/ Chief Accounts Officer
3. All present heard.
4. The appellant vide his RTI application dated 8.3.2019 had sought information **from January 2010 till 8.3.2019** on the following:
  - a) *Correspondence between FTII-CPF Trust/FTII with Charity Commissioner Pune and Mumbai*
  - b) *Correspondence made with Employees Provident Fund Commissioner and Regional provide Fund Commissioner Pune*
  - c) *Correspondence and communication details between FTII, I & B Ministry and Finance Ministry*

5. The PIO (Financial matters)/CAO vide reply dated **08.04.2019** provided information of about 77 pages and 61 pages as sought in 4 (b) & 4 (c) above. Regarding 4(a), it was informed to the appellant that information was not available in accounts section.
6. During the hearing, PIO/CAO maintained that no correspondence has been by CPF Trust of FTII with Charity Commissioner/Pune or Mumbai. Further, it was brought out during the hearing that the appellant seeks to know the **correspondence between the organization i.e. FTII and the Charity Commissioner/Pune or Mumbai** and **not merely correspondence between CPF Trust of FTII and the Charity Commissioner.**

In light of the position explained at para 6 above, PIO/Administrative matters is directed to facilitate inspection of files relating to correspondence between FTII and Charity Commissioner's Office Pune and Mumbai. The inspection is to be facilitated within 10 days from issue of this order.

The appeal is therefore disposed of.

If the appellant is not satisfied with the information provided, he may file an appeal before **Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi - 110 066** within the stipulated time.
