This order shall dispose of the appeal filed by Shri Rajarshi Majumdar FATIP/A/2019/60007 in respect of ID No.33.

2. The Appellant in his application dated 21.08.2019 asked for the following information :

- (i) Report of the committee which constituted the ongoing syllabus of Film Wing and TV Wing of FTII
- (ii) Minutes of every syllabus review committee after 2014
- (iii) List of subsequent modifications made in the syllabus after 2016 in each semester
- (iv) Name of the person/body/committee who were part of above said modifications made in the syllabus after 2016 in each semester
- (v) Detailed document of syllabus approved for 2016 batch when they were admitted to FTII, with norms of every exercise and learning objective of each module
- (vi) Detailed document of the ongoing syllabus with norms of every exercise and learning objective of each module

3. The PIO {Dean (Television)}, vide reply dated 03.09.2019 informed that "By and large, the contents in TV Course are the same. According to technology change and TV industries practices, minor changes do take place. No review committee for the courses. Rearrangements of inputs on the basis of previous years' experiences."

4. In view of the above, PIO {Dean (Television)} is directed to supply the copies of ongoing syllabus with norms of every exercise and learning objective of each module to the appellant within 5 days.


5. The PIO {Dean (Films)}, vide reply dated 20.09.2019 informed that "the information/document as requested in your application is ready. These documents are of 887 pages. You are requested to deposit an amount of Rs.1774/- (@Rs.2 per page x 887) in the name of "The Accounts Officer", FTII, Pune and collect the documents/information.

6. As regard to above, it is to mention that the PIO {Dean (Films)} informed that the appellant has not yet collected the documents/information by paying the requisite fees. As such the contention of the Appellant that the PIO provided incomplete, misleading and false information does not hold ground.

The appeal is therefore disposed of.

7. Ordered accordingly.
