This order shall dispose of the appeal filed by Shri S.V. Kulkarni in respect of ID No.35..

2. The Appellant in his application dated 11.07.2019 asked for the following information :

- (i) As per the order dated 21.6.2019 I have received the interest upto 31.07.2017.
- (ii) Whether the interest have been paid or not from the date of retirement i.e. 31.7.2017 to 31.5.2019 on Institute contribution i.e. amount of Rs.60,373/-
- (iii) Whether the interest have been paid or not from the date of retirement i.e. 31.7.2017 to 31.05.2019 on interest of Rs.37287/- and Rs.18730/- on individual contribution and institute contribution
- (iv) As per the Swamy Hand Book (Page No.312) - Interest :- If the Payment cannot be made within one month after retirement or after the date of receipt a application in the prescribed form, whichever is later due to administrative reasons, interest is payable on the balance upto six month for the period beyond one month. Interest can be allowed upto one year by the head of Accounts Officer and beyond that period by the immediate superior to the Head of Accounts Office.
Therefore, it is requested that as per Swamy's rule I may be paid interest on Institute contribution & interest on institute on

interest on individual and institute contribution upto last payment Rs.116390/-

3. The PIO, vide reply dated 21.08.2019 mentioned that "the information sought being hypothetical in nature, it can not be provided under RTI."


4. The information sought be clearly specified, so as to enable PIO to provide the relevant information. The Appellant is, therefore, advised to contact the respondent PIO (CAO).

5. In view of the above, PIO (CAO) is directed to supply the available information to the appellant.

The appeal is therefore disposed of.


