**Instructions for short listed candidates**

All short listed Candidates **MUST** send self-attested scan copy of the originals of the following documents by **2<sup>nd</sup> November 2020**. Under **NO** circumstances will candidates be allowed to appear for the **Orientation and Interview** if they fail to send the valid documents mentioned below till the due date:

1. Class 10th and 12th Certificates and Class 10th and 12th Mark Sheets
  2. Degree Certificate/s and Degree Mark Sheet/s
  3. Caste certificate in case of SC / ST / OBC-NCL (Wherever applicable)
  4. Certificate of Benchmark Disability (Wherever applicable)
  5. Photo ID proof - Pan Card or Aadhar Card or Passport or Driving Licence or Voter ID Card
  6. JET 2020 Admit Card or JET 2020 Application Form or JET 2020 Result/Score Card

### **Exceptions on account of circumstances arising due to Covid-19**

#### 1. Appeared/Appearing Graduates

Candidates who are yet to appear or have appeared and are awaiting results of their final year Bachelor's degree or equivalent examination, if selected, are allowed to join the programme, only if they submit valid documents regarding the same. The status of admission of all such candidates will only be provisional. If any information provided in this regard is found unsubstantiated or incorrect at any later point in time, the candidature/admission will be cancelled and the candidate can be debarred from appearing in any examination of this Institute in future. Admission of appeared/appearing graduates will be subject to passing in graduation or equivalent examination.

The decision of FTII in this regard will be final and binding on all concerned.

#### 2. Medical Test

Candidates short listed for Orientation and Interview are required to undergo a Medical Test at Pune as mentioned in the selection criteria. However, in view of Online process for admissions this year, the candidates are required to take the medical test at their place.

It will be mandatory for the candidate who gets selected through the admission process, to produce/submit medical certificate issued by the Competent Authority within fifteen days from the date of declaration of final results on FTII website failing which the selection of the candidate will be cancelled. The competent medical authority could be a Medical officer not below the rank of Gazetted officer (Civil Surgeon/ District Medical Officer / Medical Superintendent / Medical Officer of equivalent status etc.) OR Officer Grade I of the Central/State Health Services who is In-Charge of the Central/State Government Hospitals in far-flung remote areas.

FTII reserves the right to have the candidate re-examined at later stage at Pune by a Medical Officer appointed by FTII, even after the admission (if and when the situation permits). In case the candidate is required to undergo any further medical examination she/he will have to do so at her/his expense. If a



candidate is found unfit on medical/physical fitness grounds during examination at later stage, his/her admission will stand cancelled with immediate effect.

The decision of FTII in this regard will be final and binding on all concerned.

A format for requesting the medical authority for medical examination and certificate will be communicated in due course.

**Note**

Candidature can be cancelled if any discrepancy is found between the self-attested scan copy of the submitted documents and the original copies of the same presented for scrutiny at the time of reporting for admission to FTII.

**Candidates claiming OBC-NCL** status may please note that the OBC certificate, including non-creamy layer status should have been issued on a date within **one year** before the closing date of receiving applications for JET 2020 i.e. 31.01.2020 or thereafter, i.e. any time after 1.02.2019.

**Candidates claiming PwD reservation** should submit latest certificate in the prescribed form which should have been issued on a date within **six months** before the closing date of receiving applications for JET 2020 i.e. 31.01.2020 or thereafter, i.e. any time after 1.08.2019. It is compulsory for PwD candidates to appear before the board constituted by FTII (for details please refer to sub-point 5 of point 9 (Reservation Policy) at page 32 of the FTII Prospectus 2020). The report of the board will determine the decision regarding the admission of the candidate.

Further details regarding the **Orientation and Interview** shall be communicated to shortlisted candidates on their registered e-mail ID.
