Applications of only such officers will be considered as received through proper channel and accompanied with (i) bio-data (in duplicate) (ii) photocopies of up-to-date CR dossiers/ ACRs/ APAR of the official for the last five years, duly attested (original ACRs may not be sent) (iii) cadre clearance (iv) vigilance clearance/ integrity certificate and (v) statement giving details of major or minor penalties imposed on the officer, if any.

The last date of submission of applications complete in all respect is 45 (fourty five) days from the date of publication of advertisement in Employment News/Rozgar Samachar.
