This order shall dispose of the appeal filed by Shri K. Jagdeeswaran in respect of I.D. No.41.

2. The appellant vide his RTI application dated 24.10.2019 had sought information on the following :-

- (i) Request for inspecting related files, file noting, to take notes and to take attested photocopies of the required pages regarding SKIFT courses conducted by FTII
- (ii) Please provide attested photocopies of the following documents regarding number of officials and other individuals attended officially and travelled by Air India flight
  - (a) Approval of the competent authorities to conduct SKIFT course in the month of July 2017
  - (b) Approval of Bills and invoices of Air India ticket booking and paid by FTII or any staff or any other individuals and got reimbursement
  - (c) List of candidates who attended the SKIFT course


3. In his RTI appeal, the appellant accepts that the information was provided by CPIO/Administrative Officer and PIO/CAO. However, further the appellant mentions that the reply for Item no.2 (ii) (b) received from PIO/CAO is contradictory with the reply received from PIO/Administrative Officer.

4. As regards, Item no. 2 (ii) (b) of the RTI application, PIO/CAO is directed to supply the requisite information within 10 days. The appeal is therefore disposed of.

9. Ordered accordingly.

If the Appellant is not satisfied with the provided information, he may file an appeal before Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi – 110 066 within the stipulated time.
