This order shall dispose off the appeal filed by Shri Vinay Babu FATIP/R/2018/50032 in respect of ID No.16.

The appellant in his application dated 26.06.2018 mentioned that he wanted to know the over all marks of all students who had given interview at the Film and Television Institute of India, Pune and he also want to know his marks task wise, tasks were conducted from 8th June 2018 – 13th June, 2018 and also he wanted to know that what he had done wrong in orientation and interview.

The CPIO, vide his reply dated 24th July, 2018 stated that the information required by you can only be disclosed once the admission process is complete in the month of August, 2018. The candidate was advised to keep track of FTII website for the same.

The CPIO has contended that till the examination process (including declaration of final result) is complete, any information regarding cut-offs/marks secured by a candidate can't be disclosed. Preservation of confidentiality of sensitive information such as marks secured by any candidate was of paramount importance as disclosing any information before declaration of the final result may compromise the integrity of the examination process. The CPIO further contended that it was informed to the candidate that information can be made available to him after the examination process is complete in the month of August, 2018.

The CPIO has stated that since the admission process for the year 2018 at FTII, Pune is completing in August, 2018 following information will be made available to the candidate:

- 1) Marks obtained by the candidate, Vinay Babu at various stages of the examination process.
- 2) Cut off marks.

The CPIO is directed to provide information at 1) and 2) above within 10 days.

The appeal is therefore disposed off.

If you are not satisfied with the information provided, you may file an appeal before Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi – 110 066 within the stipulated time.
